

KingFisher Kennels Puppy Purchase Agreement

The buyer hereby agrees to purchase the puppy named (_____) from KINGFISHER KENNELS for the price of (\$ _____) plus shipping.

1. All puppies require a \$500.00 deposit, until born and then the deposit goes up to 50% the cost of the puppy. Method of payment can be Visa or Master card, U.S. Postal Money Orders, Cash, & Personal Checks.

2. Choice of puppy is determined on a first come (**deposit received**) first to choose basis.

3. All puppies will be sold without "breeding rights" and come with AKC Limited Registration. If you desire to arrange "breeding rights" (AKC Full Registration) this additional privilege must be discussed and mutually agreed upon by buyer and seller at time of purchase and a fee of (\$ _____) will be added to the purchase price of the puppy. Buy purchasing "breeding rights" the seller in no way guarantees that the said puppy will be fertile. No monies will be refunded for a infertile non-breeding dog.

4. Deposits are **NON REFUNDABLE**. If something happens to your chosen pup or if the sex or color you prefer is not available from this litter you will be given choice of a pup from any upcoming litter. **If you change your mind and do not/can not get puppy you forfeit your deposit.**

5. All puppies are shipped at expense of buyer, shipping costs to be added to the puppy price are (\$ _____). Shipping includes puppy airline flight, veterinarian health certificate, and crate. Breeder Guarantees safe arrival of said puppy to destination.

THIS PUPPY IS GUARANTEED AS FOLLOWS:

1. To be in good physical condition for the first 72 hours after the time of shipping. The buyer agrees to have the puppy examined by a veterinarian within 72 hours after the delivery time for a complete physical examination. Failure of buyer to take said puppy for a physical examination to the vet within 72 hours of shipping voids puppy warranty in full. If a veterinarian finds the puppy to have a contagious disease or to have a serious physical condition other than a bacterial

infection such as Coccidia or Giardia which are easily treated, the seller will replace the puppy with another puppy of comparable or better quality. The seller reserves the right to a second veterinarian opinion at the expense of the seller. No monies will be refunded. Buyer is responsible for all Veterinarian costs, as well as shipping costs of the replacement puppy.

2. Puppies are considered high risk for Coccidia and Giardia. These health issues are easily treatable, and are not serious. They are often brought on by the stress of shipping, a new home, new food, new people, change of climate or surroundings. Shipped puppies seem more prone to showing symptoms of Coccidia or Giardia. **All puppies are treated for Coccidiosis and Giardia before they leave.** Treatment however is not a guarantee the puppy will not respond to the above issues. They can arise. But if they do, they are rarely serious (even though seeing blood in the stool would appear serious) and are easily treated. Kingfisher Kennels will not cover the treatment for them.

3. To be free from any genetic / hereditary defects that cause death or serious impairment of the vital functions in the puppy until said puppy is two years of age. If such an inheritable defect is documented by a Veterinarian and presented to the seller with sufficient supporting evidence, the buyer will be entitled to a replacement puppy of the same sex, of comparable or better quality, when available from same or upcoming litter, after the first puppy is returned to seller. No cash refunds given and Seller does not pay any vet bills or return shipping costs.

THE BUYER AGREES:

1. To at all times use the kennel name " KINGFISHERS " as the kennel prefix in the registered name of the dog as well as the leading prefix in said dog's name in any advertisement of this dog whether in print or photo publication.
2. In the event that the dog is later sold, or otherwise transferred from the possession of the buyer, for whatever reason, the seller will have the absolute right of first refusal to repurchase the dog.
3. **Maintain up to date vaccines and regular routine worming.**

The buyer and seller agree that this is the full and complete agreement that exists between the parties for the sale of this dog.
